Purpose: Pursuant to Article 3.A.6, 7 and 8, Article 5.B.2, Article 6.C, Article 7.C.3 and D, Article 9.C.3, Article 10 and Article 11, the Commission shall promulgate reasonable and lawful uniform rules to facilitate and coordinate implementation and administration of the Cosmetology Licensure Compact Member States including through the development, maintenance, operation and utilization of a coordinated database and reporting system. Member States must participate in the Data System, including through the submission of a uniform data set on all individuals to whom this Compact is applicable.

4.1 Uniform Data Set: Notwithstanding any other provision of state law to the contrary, a member state shall submit a uniform data set to the Data System for all individuals to whom this Compact is applicable. Such data set shall include:

- A. Identifying Information, which shall include but is not limited to:
 - 1. Full Legal Name including:
 - i. First Name
 - ii. Middle Name or Middle Initial if available
 - iii. Last Name
 - iv. Suffix, if applicable
 - 2. Social Security Number
 - 3. Full Date of Birth (MM/DD/YYYY)
 - 4. Address of Primary Residence:
 - i. Primary Address Number and Street Name
 - 1. Include Directionals in Street Name, if applicable
 - ii. Secondary Address Identifier, if applicable (ex. Apt or Unit #)
 - iii. City
 - iv. State
 - v. Postal Service Zip Code
 - 5. Email Address
 - 6. Phone Number (10 digits)
- B. Licensure Data, including but not limited to:
 - 1. Member State or Jurisdiction
 - 2. License Type
 - 3. License Number (formatted as Home State followed by number)
 - 4. Initial Multistate License Issuance Date
 - 5. Multistate License Expiration Date
 - 6. License Status
 - i. Active or Inactive
- C. Adverse Actions against a Multistate License or Authorization to Practice including but not limited to:
 - 1. Encumbrances, including:
 - i. Suspension
 - ii. Revocation
 - iii. Surrender
 - 2. Effective dates of Adverse Action;
- D. Existence of Current Significant Investigative Information
- E. Non-confidential information related to alternative program participation.

4.2 Reporting of Licensee and Licensure Data:

- A. Member States shall submit the uniform data set as required by Section 4.1 on or prior to the close of business, local time, on the last business day of each week. Exceptions to the reporting timeline may be approved by the Executive Committee or Compliance Committee for good cause shown.

- B. If a Member State takes adverse action, it shall report the action taken to the Data System within five (5) business days of the date the action was taken. The administrator of the Data System for the Commission shall notify the home state of any adverse actions by Remote States.
- C. Public access to data held in the Data System shall be limited to verification of compact privilege(s) held by individuals.
- D. The Home State shall be responsible for verification of uniform requirements for participation as described in Section 3 and 4 of the Compact.
- E. The existence of Current Significant Investigative Information pertaining to a Licensee in any Member State shall only be disclosed to other Member States.
- F. In the event a licensee asserts that any data submitted to the Data System is inaccurate, the Commission shall have no obligation to investigate or substantiate such claims. The licensee's remedies are limited to those available under the laws of the Member State responsible for submitting the contested information to the Data System.
- G. Any information submitted to the data system that is subsequently required to be expunged by the laws of the member state contributing the information shall be removed from the Data System in a manner consistent with such requirements.
